**“Pardons are ending...
Apply before it's too late”**

Pardon companies with an ad that states, “Pardons are ending... Apply before it's too late”.

Scam: these companies are using a scare tactic to entice you to sign up. The word ‘pardon’ is no longer used... it is now called a Record Suspension. This scam is used only by deceptive companies.



“Have your application processed faster if you pay more money”

Pardon companies that promise to have your application processed faster if you pay more money.

Scam: these companies are making false promises to entice you to sign up.

The Parole Board of Canada will not accelerate the review of your application. This scam is used only by deceptive companies.



“Asks for money before getting all the information about your conviction”

Pardon companies that ask for money before getting all the information about your conviction.

Scam: these pardon companies are taking your money before determining your eligibility. Taking your money before knowing if you are eligible for a pardon is sneaky. This scam is used only by deceptive companies.

OK, so now you know the top 3 pardon scams to watch out for. Next step is to make sure the pardon company you hire passes these requirements...

Knowledgeable, discreet and caring service representatives.

You need to feel confident that your best interests come first. Look for proof the pardon company you are selecting puts customer service as #1 priority.

Proven policy of honesty and integrity.

Seek out staff who fully explain the details of a Record Suspension and Travel Waiver application. Demand service with no hidden costs and no surprises. Ensure you will know what to expect from your selected pardon company right from the very beginning.

Experts who know government forms and red tape.

Look for proven experience with application submissions to the Parole Board of Canada. Hire experienced pardon companies who process the quickest way possible. Remember, as soon as your pardon is granted, your criminal record will no longer appear on your file.



Do your homework on EVERY company you are thinking of dealing with in order to avoid being scammed.

Search the pardon company name on the Better Business Bureau website and search for reviews on the internet.

For example, enter ‘pardon now enterprises review’ on Google.com. Or pardon company ‘x’ scams, then look at the results for evidence of good or deceptive services.

Bonus: Pardon Eligibility Cheat Sheet

Be sure your pardon company asks pertinent questions like the ones below. Without this info, there's no way for them to know if you are eligible.

When did your last conviction occur?

What was the nature of your last conviction?

How many convictions do you have and what are they?

What conditions did your sentence include?

Did any of your sentences include jail time?

If so, for how long and where were you sent?

Have you tried to apply for a pardon previously?

Do you have any current charges that have not been heard in court?

Your answers to these important questions determine your eligibility for pardon.

Once your eligibility has been determined, be sure you know the step-by-step procedures the pardon company will follow to complete your successful application.

Pardon procedures must include:

1. The amount of money that is owing immediately.
2. Plus any money that will be billed later on.
3. Parole Board filing fees.

Be sure they tell you about the filing fee that the Parole Board charges. The amount is over \$600.00 and is not needed till the application is fully complete and ready to be sent to Ottawa.

Unscrupulous pardon companies will not tell you about money they plan on charging you later.
